ABOUT THE APPLICATION



CCCApply, the statewide online admission application center for California Community Colleges, combines individual college identity and processing with system wide consistency, compliance, and support.

The suite of admission application forms at CCCApply.org—a common Standard Application, a Spanish Application, an International Application, and a BOG Fee Waiver Application—streamlines the admission application process for students and colleges alike.

Since its introduction in the fall of 2001, CCCApply has become the choice of more than 100 of the California Community Colleges. Colleges using CCCApply typically receive 80% to 100% of their admission applications online.

FAQ'S



- 1. Once a student applies to any 1 of the 4 campuses within the Los Rios District, you CANNOT submit another application for a LRCCD campus within the same term. If you wish to attend another campus for a term you've already applied for, you can "term activate" another campus within LRCCD through their eServices account.
- 2. Students DO NOT need to submit a new application if you are continuing from term to term.
 - 3. Students who skip/do not enroll in a main term (Spring or Fall) will have to submit a NEW CCCApply application in order to enroll in courses.
- 4. High school seniors who plan to enroll after graduation and have taken an Advanced Education course MUST submit a NEW application to enroll as a first-time student entering college
 - 5. Students CANNOT create a new account if they have forgotten their login information. They must retrieve their login information by clicking on the "Forgot?" link.

Social Security Number

The Social Security Number (SSN) or Taxpayer Identification Number (TIN/iTIN) is used by the college as a means of matching student records, facilitating federal financial aid, and reporting tax-related information to the Internal Revenue System (IRS). However, it is not required for admission.

What is an ITIN?

An Individual Taxpayer Identification Number (ITIN) is a tax processing number issued by the U.S. Internal Revenue Service (IRS). The IRS issues ITINs to individuals who are not eligible to obtain a Social Security number (SSN). These taxpayers include unauthorized immigrants as well as lawfully present individuals, such as certain survivors of domestic violence, Cuban and Haitian entrants, and spouses and children of individuals with employment visas. In 2010, 3.02 million ITIN federal tax returns were filed.

Why does the federal government issue ITINs?

Federal law requires individuals with U.S. income, regardless of their immigration status, to pay U.S. taxes. The IRS provides ITINs to individuals ineligible for an SSN in order to improve compliance with tax laws.

What is an ITIN used for?

ITINs are for paying federal taxes and opening an interest-bearing bank account. An ITIN does not authorize an individual to work in the U.S. or provide eligibility for Social Security benefits.
